I. <u>General Information</u>

B. Type of Contract, Fees and Compensation

The OCBH intends to execute a one (1) year agreement to complete the work specified within this RFP. This contract will be a "Not-to-Exceed" contract and will be billed based upon tasks and man-hours established in the proposal for the work and/or activities completed.

C. <u>Deadline</u>

Sealed proposals shall be opened in public and read aloud at 10:00 AM prevailing time on January 9, 2024 at the Ocean County Board of Health, 175 Sunset Avenue, Toms River, NJ 08754. <u>Proposals shall not be accepted by facsimile transmission or e-mail UNDER ANY CIRCUMSTANCE.</u>

D. Questions & Addenda

<u>Questions must be received in writing acoppola@ochd.org</u> before 10:00 a.m. EST on January 4, 2024. Questions will not be answered over the phone.

All interpretations, clarifications and any supplemental instructions will be in the form of written addenda to the RFP and will be posted to the OCHD website. All addenda so issued shall become part of the specification and proposal documents and shall be acknowledged by the proposer in the proposal by completing the Acknowledgement of Receipt of Addenda form. The owner's interpretations or corrections thereof shall be final.

<u>All addenda are posted on this site</u>. Potential respondents are cautioned that they are responding at their own risk if a third party supplied the specifications that may or may not be complete. Respondents are urged to check this website for all posted addenda.

E. <u>Proposal Format</u>

All proposers shall be required to submit five (5) complete sets (one (1) original and four (4) exact copies) of their proposal. There is no restriction to length of proposals; however, proposers are encouraged to be as concise as possible. All proposals should include:

- 1. Qualifications: The proposer shall submit the following information to demonstrate their qualifications to perform the services described in this RFP:
 - a. All pertinent company information including Name, Business Address, Type of Organization, Authorized Representative(s), Contact Information, etc.
 - b. Personnel including resumes or professional biographies of Key Officers and other Key Project Team Leaders.
 - c. Experience of the Firm(s) including years in business, years and type of experience in related activities.
- 2. Business Proposals: Proposals to be considered shall include the following information:

Task by task cost (including total proposal cost) to provide the services outlined in the scope of work section of this RFP for the period not-to-exceed one (1) year from the date "Notice to Proceed" is issued. Costs shall be broken down on a per task basis.

3. Meetings:

Meetings, held over the phone or in person, may be a component of the tasks found in this RFP, in cooperation and interaction with the OCBH on an as necessary basis. This shall include but not be limited to an initial kick-off meeting to discuss the essential goals of the project and continuous update on the status of the project throughout the term of the contract.

4. Evaluation Criteria:

The OCBH has established an evaluation committee that will work together to develop a score card to evaluate proposals. The score card will be established and approved by the Purchasing Department prior to proposals being received.

The following criteria will be rated by the committee for each proposal. The proposal with the highest overall score will be considered the most advantageous to the OCBH.

- a. Specialized Technical Competence
- b. Past Record of Performance on similar projects
- c. Familiarity with the Contracting Agency
- d. Presentation and Understanding of the Proposal scope

The final score card will be released to the proposers, in written form by the OCBH, upon request. Any contract that is entered into by the OCBH will be required to be presented to our Board Members for approval.

If any of the evaluation criteria is incomplete or fails to address the questions in the proposal, the evaluation committee may reject the proposal. Each Proposer is responsible for reviewing technical and cost proposal requirements and preparing their responses in a clearly organized submittal.

Each technical and cost proposal is required to be in accordance with the terms of the specific RFP and shall be signed by an executive officer of the proposing organization, and, where applicable, a corporate officer of the parent organization, recognizing that both will have authority to bind the proponent.

Technical and cost proposals shall consider and be reflective of all federal, state, and local laws, statutes, ordinances, regulations, and other applicable laws that may affect cost, permitting, progress, performance or furnishing of the project including, but not limited to, applicable regulations concerning minimum wage rates, nondiscrimination in the employment of labor, protection of public and employee safety and health, environmental protection, protection of natural resources, fire protection, solid waste handling facility standards and permits, other permits, fees, and similar subjects.

- 5. Clarification of the Proposal
 - a. After the submission of proposals, unless requested by the OCBH, there will be no proposer contact permitted.
 - b. After reviewing the proposals, the Evaluation Committee may ask one, some or all of the proposers to clarify certain aspects of their proposals. A request for clarification may be made in order to resolve minor ambiguities, irregularities, informalities or clerical errors.
- 6. After the Evaluation has been Completed
 - a. All materials are kept on file at the OCBH.
 - b. The evaluation committee makes a formal recommendation to the OCBH officers and authorized staff. **Note:** An OCBH officer may sit on the evaluation committee depending on the type of project. The officer will make the recommendation along with the entire evaluation committee to the rest of the officers.
 - c. The most advantageous proposal will be chosen by the evaluation committee based on the score card evaluation.
 - d. The OCBH Officers and authorized staff may at this point accept, reject or modify the recommendation of the Evaluation Committee.

- 1) For any proposal that is accepted, a resolution will be presented to OCBH's Board for their consideration.
- 2) For all rejected proposals the proposers will be notified in writing.

F. Limits of Liability

The Ocean County Board of Health assumes no liability for any cost incurred by proposers in responding to this RFP or in responding to any further request for interviews, additional information, etc. prior to the issuance of the contract.

II. <u>State Purchasing Law Requirements</u>

A. <u>Mandatory Equal Employment Opportunity / Affirmative Action Evidence</u>

No firm may be issued a contract unless they comply with the EEO/AFFIRMATIVE ACTION REGULATIONS of PL 1975, c.127, as amended from time to time, and the AMERICANS WITH DISABILITIES ACT.

1. Procurement, Professional and Service Contracts

ALL successful vendors must submit prior to an award of the contract one of the following:

- a) A photocopy of their Federal Letter of Affirmative Action Plan Approval, or
- b) A photocopy of their State Certificate of Employee Information Report, or

- 2. Construction Contracts

- B. <u>Business Registration</u>

Note that all proposers must comply with the Business Registration requirements of the New Jersey Department of Community Affairs in accordance with <u>N.J.S.A. 25:32-44</u>. Firms must submit prior to the award of the contract a copy of their New Jersey Business Registration Certificate. Failure to do so will be cause for rejection of the firm's Proposal.

C. <u>New Jersey Pay to Play Regulations</u>

Pursuant to Public Law 2005, Chapter 271, Section 3 Reporting (N.J.S.A. 19-44A-20.27) any business entity that has received \$50,000 or more in contracts from government entities

in a calendar year is required to file an annual disclosure report with ELEC. The instructions and form are available on the ELEC website. Annual Disclosures require submission by March 30th of each year covering contracts and contributions for the prior calendar year. D. <u>Disclosure of Investment Activities in Iran</u>

F. General Insurance and Indemnity Requirements

A copy of the successful agency's professional liability insurance policy which is to be at a minimum levels of :

a) Comprehensive General Liability insurance written on occurrence form, including personal injury liability coverage, broad form property damage liability coverage and contractual liability coverage insuring the agreements contained herein. The minimum limits of liability carried on such insurance shall be \$1,000,000. each occurrence and, where applicable, in the aggregate combined single limit for bodily injury and property damage liability; \$3,000,000 annual aggregate personal injury liability; b) Automobile liability insurance for owned, non-owned and hired vehicles. The minimum limit of liability carried on such insurance shall be \$1,000,000. each accident, combined single limit for bodily injury and property damage; c) Worker's Compensation insurance, in accordance with New Jersey statutory limits, and employer's liability coverage of at least \$100,000 for each accidental injury and, with respect to bodily injury be disease, \$100,000 each employee and \$500,000 per policy year; and d) Professional Liability insurance in an amount not less than One Million Dollars (\$1,000,000) per occurrence. Professional Liability Insurance shall provide coverage for errors, omissions and negligent acts of Contractor or any person or organization for whom Contractor is legally responsible.

III. Project Description

A. <u>General Description</u>

The Ocean County Board of Health (the "Board) is seeking proposals from individuals and vendors capable of performing supplemental environmental health inspections and related

services to enforce relevant New Jersey sanitary and health laws. It is the intent of the Board to award contracts to qualified individuals and vendors possessing the necessary state licenses and certifications to perform inspections and related services in accordance with the New Jersey State Sanitary Code, and/or Public Health Practice Standards of Performance for Local Boards of Health in New Jersey (NJAC 8:52). Individuals and vendors are offering on any/all of the necessary inspections and related services.

B. <u>Responsibilities of the Proposer - Scope of Work</u>

The Board is seeking individuals possessing a REGISTERED ENVIRONMENTAL HEALTH SPECIALIST (REHS) license as required by N.J.S.A. 26:1A-41(k) and N.J.A.C. 8:7 to perform inspections and related services for the enforcement of the New Jersey State Sanitary Code. These inspections and related services include, but are not limited to:

- 1. Inspections of retail food establishments, manufacturers, and distributors
- 2. Inspections of public recreational bathing establishments
- 3. Inspections of youth camps
- 4. Inspections of body art establishments
- 5. Inspections of animal facilities
- 6. Inspections of individual subsurface sewage disposal systems
- 7. Inspections of private domestic wells
- 8. General inspections of food vendors at fairs/festivals/events
- 9. Investigation of complaints related to the public health nuisance code, Ocean County Ordinance 94-1, Ocean County Ordinance 83-1, New Jersey Smoke Free Air Act, and any other rules and regulations within the purview of this Agency.
- 10. Any other inspection or related services as required by the New Jersey State Sanitary Code.

All inspections and related services shall be supervised by the Ocean County Board of Health Environmental Health Coordinator or Assistant Environmental Health Coordinator.

Hours of Work- The Board requires that the successful proposers provide inspections on an as needed basis 7 days a week, at any hour that may be necessary to perform the inspection during the regular business hours of the assigned establishment. All inspections must be performed in a timely manner. It is the responsibility of the successful contractor(s) to ensure coverage for the appointed day and time. All arrangements, communications and mobile telephones are to be managed by the on-site inspection agency with the approval of the board. Emergency services during off hours are not required and are to be performed by existing OCHD personnel.

Experience and Qualifications- Proposers must provide evidence of possession of an ACTIVE REHS license issued by the New Jersey Department of Health. All proposers must submit a resume demonstrating experience and qualifications and a statement of the knowledge possessed by the agency and/or individual in providing environmental health inspections and related services.

<u>Price schedule</u>- The following are the categories which require established price per inspection/event. Rates would include all direct and indirect costs associate with the performance of this work. The rate would include travel and any subsequent or follow up work that may be required (reinspection's and revisits).

Ownership disclosure- All contractors shall comply with all laws governing the disclosure of all stockholders or partners as included in PL 1977, Chapter 33.

Proposal Review-Proposals will be reviewed once the proposal opening has concluded. Additionally, proposal results are available in the Ocean County Board of Health on the day following the openings for any interested party that may wish to review them. Requests for proposal tabulations will not be honored. In person requests for copies of proposal results will be provided in accordance with the Board policy for copies.

Informalities- The Board reserves the right to reject any and all proposals, to waive any informality in proposal, to accept in whole or in part such proposal or proposals as may be deemed in the best interest of the Board.

<u>Modifications and Withdrawals</u>- Telegraphic or Electronic proposals will not be considered. Proposals may be withdrawn on written request received from the proposer prior to the time fixed for opening. No right for withdrawal exists after the proposals has been opened. Written request shall be signed by the proposer or proper corporate officers.

<u>Availability and Response</u>- The successful proposer shall respond in a timely manner, within forty-eight (48) hours.

<u>**Transitional Period-**</u> In the event services are terminated by contract expiration or by voluntary termination by either the Contractor of the Board, the Contractor shall continue all terms and conditions of said contract for a period not to exceed thirty (30) days at the Board's request.

<u>**Copies of Proposal</u>**- Proposers shall submit to the Ocean County Board of Health an original and four (4) copies of its proposal at the time and place more specifically set forth in the Notice to Proposers.</u>

EXHIBIT A MANDATORY EQUAL EMPLOYMENT OPPORTUNITY LANGUAGE N.J.S.A. 10:5-31 et seq. (P.L. 1975, C. 127) N.J.A.C. 17:27

GOODS, PROFESSIONAL SERVICE AND GENERAL SERVICE CONTRACTS

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable, will not discriminate against any employee or applicant for employment because of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex. Except with respect to affectional or sexual orientation and gender identity or expression, the contractor will ensure that equal employment opportunity is afforded to such applicants in recruitment and employment, and that employees are treated during employment, without regard to their age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex. Such equal employment opportunity shall include, but not be limited to the following: employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the Public Agency Compliance Officer setting forth provisions of this nondiscrimination clause.

The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex.

The contractor or subcontractor will send to each labor union, with which it has a collective bargaining agreement, a notice, to be provided by the agency contracting officer, advising the labor union of the contractor's commitments under this chapter and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.

The contractor or subcontractor agrees to make good faith efforts to meet targeted county employment goals established in accordance with N.J.A.C. 17:27-5.2.

The contractor or subcontractor agrees to inform in writing its appropriate recruitment agencies including, but not limited to, employment agencies, placement bureaus, colleges, universities, and labor unions, that it does not discriminate on the basis of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex, and that it will discontinue the use of any recruitment agency which engages in direct or indirect discriminatory practices.

The contractor or subcontractor agrees to revise any of its testing procedures, if necessary, to assure that all personnel testing conforms with the principles of job-related testing, as established by the statutes and court decisions of the State of New Jersey and as established by applicable Federal law and applicable Federal court decisions.

In conforming with the targeted employment goals, the contractor or subcontractor agrees to review all procedures relating to transfer, upgrading, downgrading and layoff to ensure that all such actions are taken without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex, consistent with the statutes and court decisions of the State of New Jersey, and applicable Federal law and applicable Federal court decisions.

The CONTRACTOR shall, at its own expense, appear, defend and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection In any and all complaints brought pursuant to the COUNTY'S grievance procedure, the therewith. CONTRACTOR agrees to abide by any decision of the COUNTY which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the COUNTY or if the COUNTY incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the CONTRACTOR shall satisfy and discharge the same at its own expense.

The COUNTY shall, as soon as practicable after a claim has been made against it, give written notice thereof to the CONTRACTOR along with full and complete particulars of the claim. If any action or administrative proceeding is brought against the COUNTY or any of its agents, servants and employees, the COUNTY shall expeditiously forward or have forwarded to the CONTRACTOR every demand, complaint, notice, summons, pleading, or other process received by the COUNTY or its representatives.

It is expressly agreed and understood that any approval by the COUNTY of the services provided by the CONTRACTOR pursuant to this contract will not relieve the CONTRACTOR of the obligation to comply with the Act and to defend, indemnify, protect and save harmless the COUNTY pursuant to this paragraph.

It is further agreed and understood that the COUNTY assumes no obligation to indemnify or save harmless the CONTRACTOR, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this Agreement. Furthermore, the CONTRACTOR expressly understands and agrees that the provision of this indemnification clause shall in no way limit the CONTRACTOR'S obligations assumed in this Agreement, nor shall they be construed to relieve the CONTRACTOR from any liability, nor preclude the COUNTY from taking any other actions available to it under any other provisions of this Agreement or otherwise at law.
