Chairman Mallon congratulated Dr. Avinash Gupta for being awarded the Pride of Jharkhand on Jharkhand Foundation Day. Dr Gupta was one of three nominated for this award based on his dedication to community service and being actively involved in various non-profit organizations. Mr. Regenye spoke about a letter that was sent to the State regarding funding for our Ryan White Aids Clinics. Currently, the Ocean County Health Department is subsidizing this clinic about \$250,000:00 -\$300,000.00. We are also the only County that operates a Ryan White Clinic and our funding has been decreasing but our clinic population need has increased due partially to migrants. Most Ryan White Clinics are housed within hospitals, FQHC's or other Care facilities that are able to bill charity care and private insurance much more successfully. Health

Mr. Regenye introduced Meg McCarthy-Klein and Matt Holland to talk about their success with our Diabetes Program. Meg McCarthy-Klein spoke about their first co-hort with the program and congratulated Chaya Kaszirer, Anna Papson and Susan Strack and presented them with certificates by being in the program and their hard work and dedication to it; they accomplished their goals with exercise and reducing body weight and reduced their risk of Type 2 Diabetes by 58%. A second co-hort will be starting soon.
